# **SPECIAL NOTICE**

EFFECTIVE JANUARY 1, 2017 – GRINDABLE MATERIALS WILL ONLY BE ACCEPTED AT THE WOLFE LAKE LANDFILL.

\*Regular tipping fees continue to apply. Materials included:

- mattresses
- furniture
- bulky material including boats

The Township brings in an industrial grinding company to grind large, bulky materials in the landfills in an effort to reduce the amount of waste in the landfill, extend the life of the landfill and lower the operating costs overall. The material left from the grinding is then used for landfill cover, further reducing operating costs of purchasing cover.

Expenses are occurred when transferring material from one landfill to the other in preparation of the grinding equipment arrival. By having all materials at one location, this will improve the efficiency of this operation and save time, money and provide a safer working environment.

Thank you for working together to extend the life of the landfills and help maintain a working budget that is affordable to the Township.

#### **Ontario Electronics Stewardship**

The Township of Nipissing has an agreement with the Ontario Electronics Stewardship for the diversion of electronics from the Landfill Sites at no cost to the Township. The Township receives payment for each full bin picked up through this program.

Since enrolling in the program in 2012, the Township has received the following payments:

Total received to date:	\$6,159.00
Bear Creek Landfill Site	\$3,024.00
Wolfe Lake Landfill Site	\$3,135.00

Thank you for your continued participation in this program and helping to prolong the life of our Landfills.

#### **Stewardship Ontario**

Each year the Township reports all waste diverted from each landfill site to Stewardship Ontario. The amount of waste, recycling, electronic waste and the number of visits to the landfill sites are recorded as well as a breakdown of the tonnage of recycled materials.

From this data, Stewardship Ontario provides all participating municipalities with quarterly payments based on number of households. The funding for this program comes from fees paid by the manufacturers of recyclable materials collected.

Since enrolling in this program, the Township of Nipissing has received \$57,169.06. It is estimated that \$33,767.40 will be received for 2016.

These amounts are utilized in the Landfill budget to lower the operating costs.

## **Bear Wise**

Black bears live in most parts of Ontario. Chances are wherever you live, visit or spend your leisure time, you will be near bears or bear habitat. For your own personal safety, and for the well-being of bears, it is important that you learn about bears and their behavior. Know how to prevent and handle potential encounters with bears. Be safe, be responsible, be Bear Wise. **ontario.ca/bearwise** 

Bear Watching at Landfill Sites – When people watch bears in the wild they should never forget that these are wild animals that must be treated with caution. Do not feed or approach bears as they are unpredictable and dangerous at close quarters.

\*\*Please remember that daily closing procedures include ensuring everyone has safely exited the landfill. This procedure begins 15 minutes prior to closing. You will be asked to leave during that time.

# Fire Prevention Week is October 9 – 15, 2016.

# This year's theme is **Don't Wait – Check the Date!**

Ontario law requires that working smoke alarms be located on every storey of the home and outside all sleeping areas. Your safety is your responsibility. Only *working* smoke alarms save lives. In fact, smoke alarms can increase your chances of surviving a fire by up to 50%!

Make sure you:

- Test smoke alarms monthly.
- Change the batteries once a year.
- Replace smoke alarms after 10 years.
- Develop and practice a home fire escape plan with everyone in your household.

# **Important Smoke Alarm Safety Facts**

- All Ontario homes, cottages, trailers and/or occupancies with sleeping areas whether owneroccupied or rented, must have a working smoke alarm on every storey, and outside all sleeping areas.
- If anyone in the household sleeps with the bedroom door closed, install an alarm inside their bedroom.
- Never remove the batteries from smoke alarms. If nuisance alarms are a problem, try moving the alarm to another location or purchase an alarm with a hush feature that temporarily silences the alarm.
- Make sure everyone in the household knows what to do if the smoke alarm sounds.
- Smoke alarms can be electrically powered, battery powered, or a combination of both. If you are installing an electrically powered alarm it is recommended that it have a battery back-up in case of power failures.
- Most smoke alarms employ either ionization or photo-electric technology. Ionization alarms
  may respond slightly faster to flaming-type fires, while photo-electric alarms may be quicker at
  detecting slow, smoldering fires.



Replace Smoke Alarms Every 10 Years

**Fire Prevention Week** Oct. 9-15, 2016 Age matters when it comes to your smoke alarms. Check the manufacture dates on your smoke alarms today!





A closed door may slow the spread of smoke, heat and fire.



Test smoke alarms at least once a month by pushing the test button.



Install smoke alarms in every sleeping room and outside each separate sleeping area. For the best protection, make sure all smoke alarms are interconnected. When one sounds, they all sound.



If the smoke alarm sounds, get outside and stay outside. Go to your outside meeting place.



Call the fire department from a cellphone or a neighbor's phone. Stay outside until the fire department says it's safe to go back inside.
