The application affects the subject lands locally known as 2971 Highway 654 West; and is legally described as Part of Part of Lot 1 on Reference Plan 42R13617, Township of Nipissing, District of Parry Sound. The subject lands are currently developed with a detached dwelling, and were subject to a recent consent approval from the North Almaguin Planning Board. The subject lands are shown on the attached Key Map.

The purpose of the application is to rezone a portion of the subject property from the Rural (RU) Zone to the Environmental Protection (EP) Zone. The proposed EP Zone is required as a condition of the consent approval provided by the North Almaguin Planning Board. The application submission included an Environmental Impact Study that provides recommendations for areas on the subject lands to be located within the EP Zone. The proposed application implements the recommendations of the Environmental Impact Study to ensure the applicable natural heritage features are protected long term.

The Public Meeting is being held to enable interested members of the public to understand and comment on a Zoning By-law Amendment which will allow for a portion of the subject lands to be rezoned from the RU Zone to the EP Zone.

If a person or public body does not make oral submissions at a Public Meeting or make written submissions to The Corporation of the Township of Nipissing before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
