

SPECIAL MEETING OF COUNCIL

Council of the Township of Nipissing is considering a Trailer Licencing By-Law. Public input will be received during a Special Meeting of Council to be held:

Tuesday, May 11, 2021 Starting at 6:30 p.m.

Due to current COVID-19 precautions, members of the public are invited to address Council using the electronic meeting platform of Zoom, with the meeting being livestreamed to the Township of Nipissing YouTube channel.

- Members of the public wishing to make a presentation to Council regarding the proposed Trailer By-Law will schedule a speaking time with the Township Office no later than Monday, May 10th at 3:00 p.m.
- 2. Members of the public may also send written submissions on the proposed Trailer By-Law, to be received at the Township Office, 45 Beatty Street, Nipissing or by email at admin@nipissingtownship.com, no later than May 7th at 1:00 p.m.
- 3. Members of the public who have scheduled to make presentations will receive a Zoom Link to the meeting by email on May 11, 2021. 10 minutes per presentation will be allowed with an additional 5 minutes per presentation for any questions or comments from Council members to the presenter.

This meeting is to gather information and feedback from the residents of the Township only. No decisions on the By-Law Draft will be made at this meeting.

As we continue to navigate through the Health Emergency for Covid-19, the following restrictions have been put in place:



Stay-at-home order

A province-wide declaration of emergency and a stay-at-home order are in effect as of April 8 at 12:01 a.m.

Township Office - closed to the public

The Township Office will be staffed and operating during regularly scheduled hours however will be closed to all public access. The drop slot in the front door of 45 Beatty Street will be available for those wishing to drop off payments (cheques accepted only) or forms.

All items received through the drop box will be quarantined for a minimum of 72 hours before being processed. Telephone and email will be monitored during normally scheduled hours. 705-724-2144 or admin@nipissingtownship.com.

Council understands that these are challenging times for everyone and continues to monitor the changing situation, responding to all legislated requirements in every effort to maintain the health and safety of our residents.

Landfill Sites

Due to a resignation, one position of Councillor has been declared vacant. Council plans to appoint someone to fill the position on Tuesday, May 11, 2021.

FILING DEADLINE: Monday, April 26, 2021 at 4:00 p.m.

All applicants must be a qualified elector as defined in the Municipal Elections Act. As of Tuesday, May 11, 2021, they must be:

- A Canadian citizen
- At least 18 years old, and
- Residing in the Township of Nipissing, or is the owner or tenant of land in the Township of Nipissing, or the spouse of such a person; and
- Is not prohibited from voting (as per the Municipal Elections Act) or otherwise by law.

OPEN AIR BURNING

STARTS APRIL 1ST - OCTOBER 31ST

DAYTIME BURNING RESTRICTIONS COME INTO EFFECT APRIL 1ST OF EACH YEAR. AN OPEN FIRE IS NOT PERMITTED TO BE LIT UNTIL TWO (2) HOURS BEFORE SUNSET AND IS ALLOWED TO BURN UNTIL TWO (2) HOURS AFTER SUNRISE. PLEASE FIND A COMPLETE COPY OF THE OPEN BURNING BY-LAW 2020-42 ON THE TOWNSHIP WEBSITE.

Clothesline Program-Textile Diversion Program Bins Are Currently Unavailable Due To COVID 19 Restrictions

Clear Bags Only

The Township of Nipissing implemented a **Clear Bag Program** in 2013. Bags must be clear or tinted as long as the contents are visible to the landfill staff.

To address privacy concerns: regarding personal items related to health/hygiene waste, one solid color privacy bag – no larger than 20" x 22" (approximate size of a grocery bag) per clear bag will be accepted.

Septic & Human Waste are **NOT** accepted at the Township of Nipissing Landfill Sites.



HOUSEHOLD HAZARDOUS WASTE

An agreement is in place with the City of North Bay for Nipissing Township residents to use the Household Hazardous Waste Depot NORTH BAY at **112 Patton Street**. Open Year-Round – Wednesday to Saturday from 8am – 6pm.

The following are examples of Household Hazardous waste that **should be taken** to the HHW Depot:

- Aerosol cans
- Antifreeze
- Asphalt & roofing tar
- Automotive batteries
- Bug and tar removers
- Car and wax polish
- Degreasers
- Disinfectant
- Degradana wax ponon
- **DO NOT** bring the following items to the HHW Depot:
 - PCB's
 - Ammunition
 - Pathological Waste
 - Unidentified Products

- Drain Cleaner
- Engine / radiator flushes
- Grease & lubes
- Household batteries
- Household cleansers
- Propane tanks (big and small)
- Light bulbs (Florescent, etc.)

THE PAINT RE-USE PROGRAM is a waste reduction —re-use program located at the HHW Depot. Good quality household products can be picked by residents free of charge. This includes products such as paint, stain and varnishes.
