LOCATION OF PROPERTY: 3568 HIGHWAY 534, CON 7 PT LOT 22 REM PCL 14386 NS

PURPOSE OF APPLICATION: The purpose of the application is to create one (1) new rural residential lot on the subject lands, for a total of two (2) residential lots. The Severed Lot is to be approximately 3 hectares in lot area and have an approximate lot frontage of 305 metres on Highway 534. The Retained Lot is to be approximately 34 hectares in lot area and have an approximate lot frontage of 212 metres on Highway 534. The Retained Lot is developed with a dwelling, barn and garage. The Severed Lot is vacant. The key maps attached to this notice identify the Retained Lot and Severed Lot.



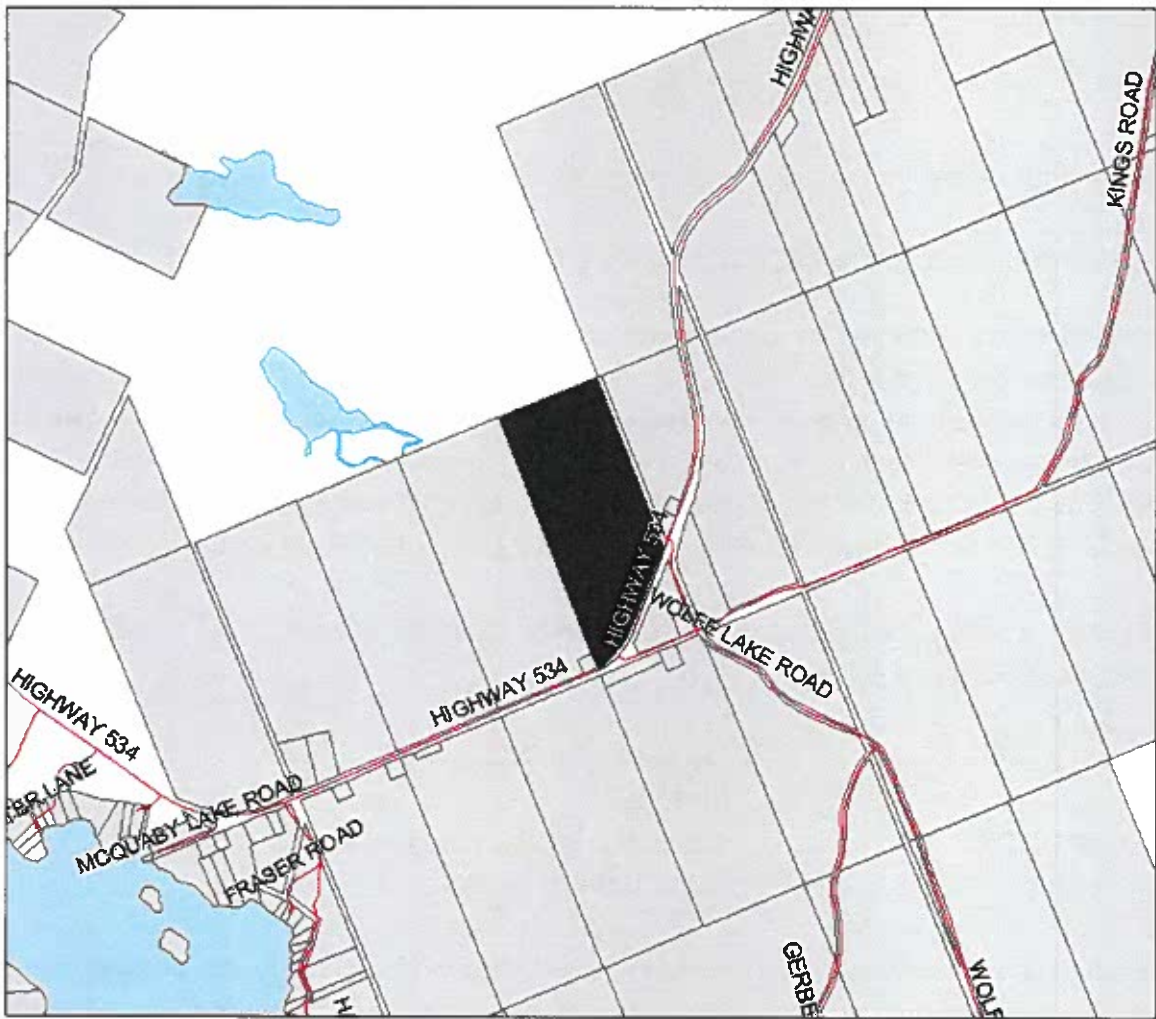
