Delegation Request - Municipal Food Waste Diversion Program with Federal Funding

Good afternoon.

My name is Jacob Hanlon, and I am the Municipal Program Coordinator at Food Cycle Science. Our company provides municipalities with innovative solutions for residential and commercial food waste diversion to reduce the amount of organic waste going into landfills.

I would like to submit a delegation request so that Council may hear about our food waste diversion programs and funding opportunities.

For more context, FoodCycler has received federal funding from the Impact Canada / Agriculture and Agri-Food Canada Food Waste Reduction Challenge to expand our municipal programs. We are a trusted solutions provider to over 70 municipalities across Canada, and we are seeking additional implementation partners to be part of this program which comes with direct investment into your community to offset the cost of the program. FoodCycler's technology transforms food waste into a natural soil amendment in hours. About the size of a bread maker, the FoodCycler runs anywhere with a plug, usually in a kitchen, garage, or basement. Food waste weight and volume is reduced by ~90%, leaving users with a pathogen-free and sterile biomass that has many beneficial uses (E.g., natural fertilizer for one's garden).

For municipalities, no green bin collection or processing infrastructure is required, landfill lifespan is extended, and GHGs are reduced by 95% vs. sending food waste to landfill. Your residents can take part in an innovative solution to increasing diversion and fighting climate change, right at home.

We would like to appear as a delegation at the March 21st Council Meeting to share information with Council and see if there would be interest in participating in the Impact Canada pilot program. Please let me know of any additional resources that might be helpful such as staff reports from other municipalities, survey results, or technical documentation.

We appreciate your time and consideration as we await your reply.

NOHFC Intern Application, Workforce Development Stream

BACKGROUND/OVERVIEW

The Ministry of Energy, Northern Development and Mines and Northern Ontario Heritage Fund Corporation (NOHFC) have a People and Talent Program — Workforce Development Stream available to Municipalities for the placement of an Intern for a one-year term. The intent of the Workforce Development Stream is to strengthen and develop Northern Ontario's workforce through business partnerships by offering internships.


This program is eligible for a placement of up to 52 weeks and is available to new entrants to the work force, those who are transitioning to a new career or are currently unemployed or underemployed entering a new field. Other requirements are that the applicants be at least 18 years of age and reside in and be legally entitled to work in Canada.

This program could provide a one-year intern to work and train in the municipal office providing administrative assistance to all departments as well as taking the lead in the Nipissing Township Museum and supporting the Recreation Committee with new programming.

The lack of consistent staffing within the Museum has been identified by the Board as a concern for ongoing cataloguing efforts, programming efforts and out of season planning purposes. An Intern in the position of Museum Manager would provide a full-time municipal staff position to cover those requirements and allow for the expansion of cataloguing and programming in the offseason as time permits.

Where there is not a need for a full-time position for any one of the departments listed, cumulatively there is sufficient work to sustain a full-time position. With an Intern working in the position, receiving the training and helping fulfill the duties, it will add support to all departments while providing training in the municipal sector which is growing in the employment market.

In 2009 the Township used a FedNor program for a one year Intern position to fill the position that started as the Economic Development Coordinator and has changed over time to become the Land Planning and Technology Administrator, bringing a full-time position to the staff of the municipality and maintaining that employee since that internship. This is also the desired outcome for this program.



FINANCIAL IMPACT

The program provides up to 90% of eligible costs for municipalities, up to a maximum of \$35,000 for a position.

Estimated costs for 52 weeks will be \$53,126.32, including Mandatory Employment Related Costs (MERCs). With \$35,000 funded through the program, this will leave \$18,126.32 to be covered by the municipal budget.


There is \$18,112.50 budgeted for the Municipal Manager in the 2023 Budget which can offset this amount and the remainder can be budgeted in the 2024 Budget.

SUMMARY

There is an identified need for additional administrative support in the Township Office, Museum and Recreation departments. The Intern program provides support to train an individual in this position for one year.

RECOMMENDATION:

That Council authorize the submission of an application for the Workforce Development Stream based on the requirements described for a one-year placement.








RE: The Reinstatement of Legislation Permitting a Municipality to Retain Surplus Proceeds from Tax Sales

Dear Honourable Steve Clark,

At its Regular Council Meeting held on March 6, 2023, Mayor Bondy brought forward a Notice of Motion for Council's consideration regarding the reinstatement of previous legislation permitting a municipality to retain surplus proceeds from tax sales. It was discussed that, prior to being repealed by the Modernizing Ontario's Municipal Legislation Act, 2017, Section 380(6) of the Municipal Act, 2001 allowed for a municipality to retain surplus proceeds from tax sales within their jurisdiction. It was further noted that the Public Tax Sale process is burdensome to a municipality who invest a considerable amount of time and money recovering these proceeds for the potential sole benefit of the Crown in Right of Ontario.

As a result of this discussion, Council passed the following resolution:

Moved by: Mayor Bondy Seconded by: Councillor Allard

That Council direct Administration to send a letter to all relevant taxation bodies, including the Ministry of Municipal Affairs, the Ministry of Finance, Essex County Council, MPP Anthony Leardi, Association of the Municipalities of Ontario and all other municipalities in Ontario urging them to re-instate previous legislation that permitted a Municipality to apply for and retain the surplus proceeds from a tax sale in their jurisdiction.



Dear Heads of Councils and Councillors.

We, the Association of Ontario Road Supervisors (AORS), are writing you on behalf of all our municipal members to raise awareness and solicit your support by objecting to a new fee proposed by Enbridge Gas. Enbridge has announced their intention to implement a new charge to third-party contractors and other utilities for utility locates. Third-party contractors will include Ontario municipalities and contractors working on their behalf. Enbridge Gas will apply a charge of \$200 CAD (plus applicable taxes) per locate request where a field locate is required. The need for municipalities and their contractors to request these locates when doing road construction and maintenance is due to utilities being present in municipal right of ways, which municipalities across the province have allowed at no cost to the utility.

Enbridge has stated that the *Getting Ontario Connected Act* passed into law in April 2022 has resulted in changes to the *Ontario Underground Infrastructure Notification System Act* and has caused Enbridge to make significant investments in associated operational investments. The concern being raised by our members, your public works staff, is that Enbridge will be just the beginning of these additional fees, with other utility companies implementing similar charges. These new charges will have significant impacts on municipal budgets.


As examples of what impacts this announcement might have on municipalities, based on 2022 municipal locate requests alone, it is estimated that this new fee would directly cost the Municipality of Central Huron approximately \$35,000 annually, the City of Belleville approximately \$90,000 annually and the Town of Espanola approximately \$7,300 annually. It is important to note that these are direct costs alone. Any subcontractors working on behalf the municipality requesting locates will be charged this same cost, and these costs will have to be borne by someone — meaning the subcontractors will put this cost back to the municipality. Then there will be the added administrative costs at both ends of the transaction. It is difficult to determine this quickly the true fulsome costs to your budget. This will also add an extra item into tendering projects, as it will create concerns on both sides on who is responsible for these costs.

By Enbridge Gas passing on these locate costs to municipalities, these costs are borne by all ratepayers across the municipality, and not only those who use this utility.

We would like to request your Council consider passing the following resolution:
