Prior to moving to Nipissing, I was a police constable with the city of Guelph. I was in this role for approximately 9 years and served the city of Guelph with honor and dignity. During my time as an officer, I received a commendation for my professionalism and received an award in 2020 for "Excellence in Mental Health".


