2024 Council Vacancy Declaration of Qualification

I, Kyle Mackeneie	an Applicant for the office of Councillor for
the balance of the 2022 – 2026 term of Council	do solemnly declare that:

- 1. I am qualified pursuant to the Municipal Elections Act, 1996 and the Municipal Act, 2001 to be elected or appointed to and to hold the office of Councillor in the Township of Nipissing.
- 2. Without limiting the generality of paragraph 1, I am:
 - at least eighteen years of age
 - a Canadian citizen
 - a resident of the Township of Nipissing or the owner or tenant of land in the Township of Nipissing or the spouse of such owner or tenant.
- 3. I am not ineligible or disqualified under the *Municipal Elections Act, 1996,* the *Municipal Act, 2001*, the *Municipal Conflict of Interest Act* or any other Act to be appointed to or hold the above-mentioned office.
- 4. Without limiting the generality of paragraph 3,
 - I am not an employee of the Township of Nipissing, or if I am an employee of the Township of Nipissing, I am on an unpaid leave of absence as provided for by section 30 of the *Municipal Elections Act, 1996*.
 - I am not a judge of any court.
 - I am not a member of the Assembly as provided in the Legislative Assembly Act or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the Township of Nipissing prior to 4:30 p.m. on the closing date for application being December 17, 2024. I understand that the Clerk of the Town of Nipissing will reject my application for the above-mentioned office if I fall to provide proof of resignation by this deadline.
 - I am not a member of the Executive Council of Ontario or a federal Minister of the Crown.
 - I am not a Crown employee within the meaning of the *Public Service Act*, or if I am a Crown employee, I have followed and will continue to follow all the relevant provisions of Part III of such *Act*.
- 5. I am not prohibited from voting at the municipal election under subsection 17(3) of the *Municipal Elections Act, 1996.*



- 6. Without limiting the generality of paragraph 5,
 - I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
 - I am not a person who was convicted of a corrupt practice described in subsection 90(3) of the *Municipal Elections Act, 1996*, from voting in a municipal election.
- 7. I am not a person who was convicted of a corrupt practice under the *Municipal Elections Act, 1996* or of an offence under the Criminal Code (Canada), in connection with an act or omission with respect to a municipal election if the Voting Day in that election is less than five years prior to December 17, 2024.
- 8. I am not disqualified from being appointed to or holding office by reason of any violations of the election campaign financial requirements or violations for not filing the financial statement pursuant to the *Municipal Elections Act, 1996*.
