 - Menu confirmation (spaghetti, meatballs, garlic bread, desserts)
 - Volunteer arrival time and setup requirements.

Advertising efforts include flyers, signage, social media posts, and potential use of volunteer t-shirts for promotion.

Updates were provided on upcoming Family Skate, including:

- Fireworks.
- DJ confirmation pending.
- Outdoor ice conditions reported as excellent.

- Hot chocolate and marshmallow station planned.
- Participation by members of the Powassan Voodoo's.
